

How do I know if the practice supervisor and practice assessor programme is right for me?

The professional bodies periodically review their standards and guidance regarding the requirements for practice supervision and assessment. This guidance is based upon the current standards (HCPC 2017; NMC 2018).

We want you to be sure that you choose the programme that is right for you. Table 1 provides guidance to help you make your decision. Table 2 illustrates the range of different programmes that may have been completed previously.

Frequently asked questions

I have just returned from a leave of absence; I have not supported students for several years. Should I complete the programme again?

A documentation update relevant for the student(s) you will be working with is definitely the best place to start. If you have completed a programme previously, you may find coming along to a face-to-face update might be preferable as you will be able to talk to colleagues about what has changed. Teaming up with a colleague to act as a 'buddy supervisor' to help your update your knowledge and skills. Some colleagues like to complete the programme again if they have had a significant absence, e.g. been working abroad, returned to practice, taken parental or carers leave.

I am an international nurse who has joined the NMC register. I am a clinical educator already, is this programme right for me?

You may find it helpful to complete the programme to help you appreciate the way in which UK health education is provided. Talk to your international lead and discuss what would be the most appropriate programme for you to complete. You may prefer a documentation update and an opportunity to attend a practice supervisor and assessor update. Your organisation may have planned for you to attend the programme as part of your induction to the organisation.

I completed a programme some time ago but cannot find my certificate. Do I need to complete the programme again?

Talk to your line manager, explain the situation, and advise as to how you have kept your knowledge and skills up to date. Complete the declaration to help you evaluate the professional development that will help you.

I will be supporting students from other education providers; do I have to do a course with them as well?

No, this programme will provide you with the information and strategies to help you supervise and assessor all learners. You may need to complete a programme specific update so that you know how to complete a learner's assessment.

I completed a practice supervisor programme in my final year, do I have to do it again?

If you completed this with Bournemouth University, provide your certificate. We maintain a database and your employer can email the administrator to confirm. You will find a refresher update helpful prior to completing the practice assessor day.

I have moved from another trust out of area, do I need to repeat my practice supervisor and assessor programme?

Complete the declaration and forward it to your line manager and practice education team so that they can update their records. Complete a documentation update that is relevant for the students you will be supporting. Do come along to an update and share your experiences with us.

Still not sure?

- Seek relevant feedback and evidence to ensure that an objective, evidence-based assessment has been made
- Maintain and develop current knowledge and expertise relevant for the proficiencies and programme outcomes being assessed
- Are able to link with academic assessors to review student progression
- Able to work with the student to inform decisions regarding assessment
- Have knowledge of the student programme and assessment process
